Call for Nominations

Bonnie E. Cone Early-Career Professorship for Teaching

The Bonnie E. Cone Early-Career Professorship in Teaching was established in 2006 and is awarded annually to a member of the faculty who has been awarded tenure within the last three years. The Professorship appointment will be for a three-year term. Each year a recipient will be named. Dr. Fumie Kato, Languages and Culture Studies; Dr. Margaret Quinlan, Communication Studies; and Dr. Peter Tkacik, Mechanical Engineering and Engineering Science, currently hold the professorship.

The appointment will include the inscription of the Professor's name on a permanent plaque, a formal announcement at the first University Convocation of the Professor's term, and the award of University resources above that normally given to faculty.

Eligibility

A faculty member must have been granted tenure in 2014, 2015, or 2016.

Nomination Process

The nomination packet should include:

- A letter from the Department Chair or Dean that documents how the faculty member has
 demonstrated a commitment to teaching at the beginning of an academic career. Specific
 examples that should be included in the nomination letter: innovative teaching techniques,
 curriculum contributions, assessment of student learning, and effective advising and mentoring.
- An updated copy of the faculty member's Teaching Philosophy.
- Current curriculum vitae.

Deadline

Nominations are due in the Office of the Provost by **March 24, 2017**, and may be sent via campus mail or electronically to Shannon.Homesley@uncc.edu.

Provost's Award for Excellence in Teaching

The Provost's Award for Excellence in Teaching is granted to an academic department, program, or unit in recognition of the collective responsibility of faculty members for maintaining high-quality teaching. The award is intended to recognize documented efforts that improve student learning and outcomes. The award of \$5,000 can be used at the discretion of the recipient unit for any purpose authorized for state appropriations. A permanent plaque has been created to move each year to the recipient unit in recognition of the award.

Nomination and Award Process

Each college Dean, the Dean of The Graduate School, and the Dean of the Library *may submit one nomination of a department, unit, or program* that has through its collective actions demonstrated an impact on student learning. Each college or unit should develop its own mechanism for nomination.

Nominations to the Provost should consist of a letter from the dean not to exceed three pages. The nomination may be accompanied by no more than ten pages of supporting documentation. An emphasis should be on the collective work of a department or unit rather than the compilation of the accomplishments of individuals. The letter and supporting materials should address the following:

- What has been the specific goal of this group with respect to providing a learning environment of the highest quality?
- What has this group done to build and sustain program quality?
- In what ways has this group advanced the teaching goals of the Division of Academic Affairs? (Examples may include, but are not limited to: active learning strategies, service learning opportunities, student research, and those goals articulated by the Division.)
- What is the evidence of improved learner outcomes?

After receiving the nominations, the Provost will seek assistance as needed to evaluate the nominations. A final decision will then be made by the Provost who will notify the dean and department or unit concerned.

Award Criteria

All University departments and programs are expected to maintain ongoing methods for enhancing and evaluating teaching performance to encourage and support effective student learning. The Provost's Award, therefore, is given to a department or program with a documented record of sustained accomplishment, commitment, and innovation in undergraduate or graduate teaching. The award acknowledges unusual efforts on the part of a department or unit to work together to deliver teaching of the highest quality that impacts student learning.

Provost's Award for Excellence in Undergraduate Academic Advising

The Provost's Award for Excellence in Undergraduate Academic Advising is granted to an advising center, academic department, program, or unit in recognition of the collective responsibility of faculty and staff members for maintaining high-quality undergraduate academic advising. The award is intended to recognize sustained efforts that assist students to achieve their educational and lifelong learning goals. The award of \$2,500 can be used at the discretion of the recipient unit for any purpose authorized for state appropriations. A permanent plaque is given each year to the recipient unit in recognition of the award.

Nomination and Award Process

Each Dean and Associate Provost may submit one nomination of an advising center, department, program or unit that has, through its collective actions, demonstrated a positive impact on students' educational and lifelong learning goals. The Dean of the College of Arts & Liberal Sciences may submit two nominations due to the higher number of advising centers, departments, programs and units eligible for the award in this college. Each college or unit should develop its own mechanism for nomination.

Nominations to the Provost should consist of a letter from the Dean or Associate Provost not to exceed three pages. This must be accompanied by supporting documentation of no more than ten pages. Emphasis should be on the collective work of faculty and staff with the advising center, department,

program or unit rather than the compilation of the accomplishments of individuals. The nomination letter and supporting materials should include the following sections:

- Philosophical Statement on Advising Excellence
- Undergraduate Academic Advising Program/Process Narrative
- Goals and objectives of the center, department, program or unit
- Description of the advising program/process
- Examples of collective work of faculty and staff in undergraduate academic advising
- Procedures used in advising evaluation
- Results/outcomes of advising evaluations
- Potential adaptations to other centers, departments, programs or units

After receiving the nominations, the Provost will seek assistance as needed to evaluate the nominations. A final decision will then be made by the Provost who will notify the center, department, program or unit concerned.

Award Criteria

All University departments and programs are expected to maintain ongoing methods for enhancing and evaluating academic advising performance to encourage and support effective students' educational progress. The Provost's Award, therefore, is given to a center, department, program or unit with a documented record of sustained accomplishment, commitment, and innovation in undergraduate academic advising. The award acknowledges unusual efforts on the part of a center, department or unit to promote collaborative efforts of faculty and staff to deliver academic advising of the highest quality that impacts students' educational progress.

Abstract

LEDs and solid-state lighting (SSL) promised significant energy savings over traditional lighting technologies. Have the energy savings claims come true? What can drive further SSL adoption to keep energy savings alive and relevant? Learn which market segments are leading and lagging in SSL adoption and why. Hear what is the next frontier in solid-state lighting.

About the Speaker

Warren is the Director, Innovation & Technology at Hubbell Lighting where he is accountable for leading and coordinating advanced R&D projects and SSL new product development (NPD) efforts. Prior to joining Hubbell, Warren was the President of the Compound Group, a business and technology advisory firm. His functional expertise in business development, strategy and operations is coupled with his technology entrepreneurship in LEDs and SSL. Warren co-founded Nitronex Corporation, a high-tech company developing advanced semiconductor

technologies. At Nitronex, he led the development of the industry's first blue light emitting diodes (LEDs) on ordinary silicon wafers. Warren previously worked at CREE, Inc. developing state-of-the-art blue and green LEDs. He is credited with producing the first solid-state blue laser in the US. Similar lasers are used in today's Blu-Ray players. He also served on the executive team at Intrinsic Semiconductor which was acquired by CREE in 2006.

Warren holds a B.S. degree in Ceramic Engineering from Clemson University and a M.S. degree from NC State in Materials Science & Engineering. He is a co-inventor on numerous US and internationally issued patents, pending patents, trademarks, copyrights and trade secrets. He has co-authored numerous scientific, peer-reviewed articles related to compound semiconductors. He has served as a technical reviewer to the US DOE for its SSL initiatives and is considered an expert in blue, green and white LEDs based on his +20 years experience in the industry.
